Message from Director

The Irish Probation Service has long recognised the value and appropriateness of social work training and values to probation work. As an organisation, we have reflected this in many practical ways over the years. In recent times, most newly recruited probation officers have professional social work qualifications. Earlier this month, the Public Appointments Service (see below) launched a recruitment campaign for new probation officers to join the Service. For the first time, applicants in this competition will have to be



registered with CORU, the Health and Social Care regulating body for Ireland. It is my intention, and that of our senior management team, that we will move more strongly and clearly in linking our professional practice to social work. As well as long being recognised as an appropriate qualification foundation for probation work, recognising social work as our core professional foundation offers us the opportunity to further develop our organisational professionalism, implementing evidence-informed practice, increasing transparency and accountability, and enabling us to achieve better outcomes for all those we serve.

As well as ensuring our own specific organisation works as effectively as possible, we need to constantly strive to work hard to deliver the best interagency co-operation in criminal justice, in order to achieve shared goals. Reflecting this imperative, the Council of Europe's 2018 *Conference of Directors of Prison Service and Probation Services* in June, in Estonia, will have the issue of probation and prisons organisations working together effectively, to achieve shared goals, as its theme. The conference will consider issues such as developing leadership in our agencies, and explore different models of collaborative working, whether prison and probation services are delivered as part of a single, 'corrections' body, or as separate entities. In Ireland of course, prisons and probation are separate entities – although both are agencies of the Department of Justice and Equality. This is similar to the situation in two thirds of jurisdictions across the Council of Europe Member States. I, with several international colleagues, have reflected on this issue in the current edition of the *Justice Trends* international magazine. It is still my conclusion that while organisational structures may help or hinder multi-disciplinary co-operation, the real ingredients of success in interagency working are more about leadership, positive commitment and trust, all of which we need to recommit to, every day.

The next edition of *Probation works* will be published in May 2018.

ACJRD is pleased to announce that **Tim Chapman** will present the 11th Annual Martin Tansey Memorial Lecture, which will be held on **Tuesday, 17th April, 2018**, in the Juror Reception Area of the Criminal Courts of Justice. The ACJRD 20th Annual Conference Report "The Brexit Impact on Criminal Justice Cooperation in Ireland" will also be launched at this event.

Tim Chapman is the current Chair of the Board of the European Forum for Restorative Justice (EFRJ) and a leading international expert on restorative justice issues. The EFRJ, established in 1998, is the leading organisation promoting the development of effective RJ policies, services and legislation in Europe. It aims to help establish and develop victim offender mediation and other restorative justice practices in the belief that every person in Europe should have the right of access to restorative justice services.

The 11th Annual Martin Tansey Memorial Lecture will be hosted by the ACJRD on Tuesday **17th April**. The lecture, which will be delivered by **Tim Chapman**, will be held in the Juror Reception Area of the Criminal Courts of Justice, Parkgate Street, Dublin 8. The launch of the ACJRD 20th Annual Conference Report, *The Brexit Impact on Criminal Justice Cooperation in Ireland*, will also take place at this event. Registration is from 5:30pm, and the event will begin at 6:00pm.

Tim Chapman spent over 25 years working in the Probation Board for Northern Ireland (PBNI), playing an active part in developing "evidence-based practice" both with adults and young people. He is the current Chair of the Board of the European Forum for Restorative Justice (EFRJ) and a leading international expert on restorative justice issues.

Friends and family of a former client, who died to suicide last year, read out a reflection and released balloons as the tree was planted, creating a beautiful contemplative moment.

This was followed up with the awards, and Tivoli are very grateful to Vivian Geiran, Probation Service, and Achmat Isaacs from the Health Service Executive (HSE) who graciously agreed to hand out the certificates. The clients appreciated the additional recognition that comes when an outside authority hands them a certificate and shakes their hand. We are also grateful to the many representatives from Probation, both the local offices and from Haymarket HQ, from the Education and Training Board, the HSE as well as local agencies we work alongside, who all came to support our clients.

It was a particular pleasure to acknowledge the achievement of 8 clients who have managed to achieve the full Major Award in General Learning at QQI level 4. This is a significant achievement and we are very proud of them. Most were unable to be present to collect their awards as they have since finished with the centre and in most cases are now working full-time.

EuroPris Workshop on Family Relations

EuroPris will hold a workshop on prisoners' family relations, on 11-12 April 2018, in Vienna, Austria. The workshop, which will be hosted by the Federal Ministry for Constitution, Reform, Regulation and Justice, will offer participants an opportunity to share good practice, and consider some recent developments in relation to children of prisoners and related issues. These will include the work of the EuroPris Family Relations expert group, and the Council of Europe draft recommendation on children of prisoners, as well as the work of the Children of Prisoners Network (COPE). Probation Service Director, Vivian Geiran, will introduce the Council of Europe draft Recommendation document, and present a concluding session on 'How to move forward?'

The Trial is exhibited in the resonant space that is Kilmainham Gaol Courthouse. Directed and produced by Visual Artist Sinead McCann, The Trial is a collaborative artwork with men from the Bridge Project, Dublin, who have lived prison experiences, and research by UCD historians, Catherine Cox and Fiachra Byrne.


